I AM A REGISTERED VOTER OF FLORIDA AND HEREBY PETITION THE SECRETARY OF STATE TO PLACE THE FULL TEXT OF THIS AMENDMENT TO THE FLORIDA CONSTITUTION ON THE BALLOT IN THE GENERAL ELECTION

TITLE: SAVE OUR FLORIDA

SUMMARY: *Protects the Quality of Life of Floridians by Preserving the Environment, a Positive Business Climate, Efficient Education System, Individual Rights, Lower Taxes and Limiting Spending on Non Floridians along with a Responsible Growth Management Policy.*

Full Text: Article I of the Florida Constitution is hereby amended adding the Following Section: Save our Florida Legislature shall prescribe, enact and enforce measures implementing this Section: 1. Right to Protect the Quality of Life in Florida

- The Environmental Quality of our Natural Resources including the Animal and Plant Life must be protected from unnecessary harm.
- The Environmental and Economic effect of any business must be considered before opening or operating 1. Environmental friendly business's must be encouraged by government policy 2. Economically depressed areas must be given assistance for economic problems.
- Business will be encouraged to create jobs but not at the risk of creating environmental hazards that would effect everyone.
- Developers can be required to help pay for public school construction costs where overcrowding exists for new or old area schools.
- The state of Florida and local School Boards must maintain proper Educational Standards and class size for all students.
- Individual Rights must be protected and equitably reimbursed for government intervention in limiting private property use.
- Polluters and others who cause damage to the environment must pay for their damages instead of the Taxpayers of the state of Florida
- Individuals who are not permanent residents of Florida and Non Citizens are not to receive state of Florida Financial Assistance unless mandated by the Federal government or needed for emergency humanitarian reasons. 1. Legislature can override this provision by a 70% majority vote 2. Reimbursement of state of Florida expenditures for Financial Assistance to non residents of Florida or non citizens must be collected when ever possible from the individuals or guardians, state or federal government or country of citizenship.
- If any portion of this section is held invalid for any reason, the remaining portion of this section, to the fullest extent possible, shall be severed from the void portion and given the fullest possible force and application on the May 1st after approval by the electorate.
