FULL TEXT OF THE PROPOSED AMENDMENT CONSTITUTION OF THE STATE OF FLORIDA AS REVISED IN 1968 AND SUBSEQUENTLY AMENDED

ARTICLE X MISCELLANEOUS <u>SECTION 28.</u>

Citizens Insurance shall be reformed as a mutual policyholder owned private company within two calendar years of this amendment passage. Citizens shall not be sold to any existing public or private insurance company.

All members of the Board of Directors and / or Executive Committees shall be Policyholders. No member of the Board of Directors and / or Executive Committees shall have been in Board or Executive capacity at the State owned Citizens; nor any "PUP" insurance firms; nor any insurer placed into receivership in the State of Florida.

The State shall have as a "cabinet level appointment" one (1) full member and Policyholders shall have at a minimum five (5) full members to the Board of Directors. Half (50%) of the Board shall be personal or commercial lines Policyholders not insurance industry or regulator neither licensed nor employed.

Citizens shall write both personal and commercial lines of property & casualty insurance as term with a maturity of 1 -30 years and / or permanent policies.
